Exhibitors understand that this application will become a binding contract upon acceptance by **ESTETICA Y SPA EXPO PR (ESE)**. Any changes to the information on this application must be provided to ESE in writing. This Agreement may be executed and delivered by facsimile and a facsimile signature shall be treated as an original.

EXHIBIT SPACE CONTRACT

In this contract, the "EXHIBITOR", an external company, rents space to the "MANAGEMENT" of ESTETICA Y SPA EXPO PR at its Event (September 29 & 30, 2024). When both parties have signed this contract, it will be constituted in a valid agreement. The MANAGEMENT reserves the right to establish more conditions, rules and regulations that are considered necessary for the general success of the Fair. The EXHIBITOR agrees to be subject to each one-off said conditions, rules, and regulation.

Use of Space. The MANAGEMENT reserves the right to reject, prohibit or expel any test that, in its opinion, does not agree with the mission, philosophy, interests and purpose of the Trade Fair. This reservation includes and is valid for everything related to the EXHIBITOR, such as employees, contractors, EXHIBITORS, agents, logos, printed material, products, advertising, vocabulary, expressions, sound levels or tone of voice, or any conduct that affect the above. The EXHIBITOR agrees to have its exhibition open and with assigned personnel during the fair's hours. If the EXHIBITOR provides its own equipment for its display, it may not exceed the measures established in the request for this contract. It cannot obscure or harm the adjacent EXHIBITORS in the opinion of the Management. You will be provided with a six (6) feet draped table, one (1) chair, two (2) three (3) feet high side walls, a eight (8) feet high back wall, a wastebasket, an electricity connection (it is not included), Booth identification sign. The area is carpeted by the Puerto Rico Convention Center. If the EXHIBITOR plans not to use some of the equipment that the MANAGEMENT provides, he must notify it on the day of the assembly, since during the days of the exhibition, neither the assembly nor the movement of equipment will be allowed. The only day for assembly is the day before the trade fair. In the exhibition area, plastic boxes, cardboard boxes or any material that tarnishes the beauty of the EXHIBITORS is not allowed. The EXHIBITOR can only use it to promote, promote or exhibit its product within the area of its exhibition, exceeding beyond its limits of the assigned area, it is prohibited. The EXHIBITOR may not assign or sublease any part of its assigned space without the prior written consent of the MANAGEMENT.

Failure to comply with the rules and regulations of this Contract will result in the alteration or removal of the exhibit at the EXHIBITOR's expense. Rental fees for services and exhibit space are non-refundable. EXHIBITORS will be subject to all laws, codes, and regulations of the authorities of the place of the event, municipal, state or others that have jurisdiction over the exhibition. The mutilation or damage of some of the equipment that the MANAGEMENT provides to the EXHIBITOR will entail a fine of not less than \$1,000.00 and/or the denial of participation in future events. The deposit or amount paid before 24 hours of assembly will not be returned to the EXHIBITOR. It is at the discretion of the MANAGEMENT if you make a credit for the next event. The event to which this credit will be awarded will be the ESTETICA Y SPA EXPO PR event. This does not include other events that the MANAGEMENT may conduct throughout the year.

CANCELLATION, TERMINATION AND REFUND POLICY:

MANAGEMENT reserves the right to issue refunds. Any deposit or payment made prior to a cancellation will be used as a credit towards the next event, except if the cancellation is made within 30 days of the first day of the event, in which case there will be no credit. IF EXHIBITOR fails to comply in any part of the terms of this Agreement, including the conditions, rules and regulations for the Event, MANAGEMENT shall have the right, without prior notice to EXHIBITOR, to immediately sell or offer for sale the exhibition space, covered by this contract, and EXHIBITOR's deposit or payment will not be a reason for credit for future events.

EXHIBITOR further understands that he will be responsible for any deficiency, loss or damage suffered to MANAGEMENT due to his failure to comply with this agreement and EXHIBITOR agrees to pay the amount to cover for said damages immediately, upon request, together with reasonable expenses and costs incurred. Furthermore, it is agreed that the current utilization of the exhibition space is essential to the success of the Event. If EXHIBITOR is unable to affect the sale of space as provided herein, Management is expressly authorized to use or cause unused exhibit space to be occupied or otherwise used as it deems most convenient for the Event without any refund, or bonus to EXHIBITOR and without releasing in any way the EXHIBITOR from any liability hereunder, and EXHIBITOR expressly agrees to pay the full amount set forth in this Contract.

Management will not be liable for the fulfillment of its obligations under this Contract as to the delivery of exhibit space if non-delivery is due to any of the following causes: the facility being damaged or destroyed by fire, dangerous or inclement weather, lack of utilities to the facility, act of God, public enemy, war or insurrections, travel limitations, strikes, lock-outs, acts of vandalism, terrorism or terrorist threats, riots or other civil disturbances, an epidemic, pandemic or other similar public health risk, the facility being unavailable due to governmental action or anticipated governmental action which would prohibit an Event such as ours or limit the capacity of the facility below our normal attendance, any other laws, rules, regulations or orders of federal, state or local government which would prohibit holding the Event at the facility or impose substantial limitations, postponement or cancellation of the Event for any other reason, or for any cause beyond the control of Management. If Management is not able to hold an Event for any of the above-named reasons MANAGEMENT is not obliged to return the money, that deposit or payment will be used as credit for the next event of ESTETICA Y SPA EXPO PR.

All EXHIBITORS must have an account with zero balance and maintain such account current 30 days prior to the opening date of the Event for advertising, products, or any other product or service previously provided by Management and/or ESTETICA Y SPA EXPO PR. Failure to bring or maintain any account current at such time will result in cancellation and termination of this Contract. No refunds will be made because of cancellation for this reason, nor will such funds be applied against past due balances, or for future events, said funds being forfeited.

LIABILITY AND INSURANCE. EXHIBITOR shall be fully responsible to pay for all injuries to persons or property damages to the convention facilities or the property of any third party which results from any act or omission of EXHIBITOR, its officers, directors, managers, employees, contractors, guests, or agents. EXHIBITOR must carry worker's compensation, comprehensive general liability including products and completed operations, independent contractors, personal injury, and blanket contractual liability with minimum limits determined by Management. This coverage must be evidenced by a Certificate of Insurance with a 30-day notice of cancellation provision to the holder and supplied to and naming Management as additional insured at least 30 days before the proposed exhibit date. It is strongly recommended that EXHIBITORS also carry insurance to cover loss of or damage to their exhibits or other personal property while such property is located at or is in transit to or from the Event site. While the Event provides security guards, this is solely as an accommodation to EXHIBITORS, and Management assumes no responsibility for any loss, damage, or injury to any property of the EXHIBITOR or to any of its officers, agents, employees, guests or contractors, whether attributable to accident, fire, theft, or any other cause whatsoever. The EXHIBITOR expressly agrees to save and hold harmless Aesthetic Congress Communications, Inc., and ESTETICA Y SPA EXPO PR, Inc., their subsidiaries and affiliates, as well as each of their officers, directors, owners, contractors, management, agents, and employees from any and all claims, liabilities and losses for injuries to persons (including death) or damage to property arising in connection with the event or with EXHIBITOR's use of the exhibit space, except such losses as may be the direct result of the gross negligence of Aesthetic Congress Communications, Inc. or ESTETICA Y SPA EXPO PR.

AVAILABLE SERVICES. On behalf of the EXHIBITORS, Management has designated official Exhibition contractors to provide the following: drayage, cartage, furniture, booth and floor decorations, signs, photographs, telephone services, and other services. The services of electricians, plumbers, carpenters, and other labor will be available and charged for at the then prevailing rates. Contractors and rates will be listed in the EXHIBITOR Service Manual to be issued separately. Management assumes no responsibility or liability for any of the services performed or materials delivered by the foregoing persons, parties, and organizations. Arrangements for these services and payments are to be made between EXHIBITOR and official Exhibition contractors. Rules and regulations for union labor are made by the local unions and these regulations may be changed at any time. When union labor is required because of building or contractor requirements, the EXHIBITOR agrees to comply with the regulations.

BUILDING. Nothing shall be posted on, or tracked, nailed, screwed, or otherwise attached to the columns, walls, floors, or other parts of the convention hall exhibit area without permission from the proper building authority. Fluids, caustic, or staining must not be used where they may damage floor coverings. Packing, unpacking and assembly of exhibits shall be done only in designated areas and in conformity with the directions of the Management, the convention hall manager, or their assistants.

INSTALLATION AND DISMANTLING. The specific requirements as to the time for installation and dismantling of exhibits will be provided in an announcement 30 days before the event. Such requirements shall be binding upon EXHIBITOR as though fully set forth in this Contract.

Attorney's Fees. Should Management incur any legal fees or costs in connection with collection of any amounts due under this Contract, EXHIBITOR shall pay all such fees and costs incurred prior to litigation. If either party brings litigation in order to enforce its rights under this Contract, the prevailing party in any litigation shall be entitled, in addition to such other and further relief to which it is entitled, to an additional reasonable sum for its attorney's fees and costs.

AGREEMENT. This Agreement shall be construed under the laws of ESTADO LIBRE ASOCIADO DE PUERTO RICO. The parties agree that jurisdiction and venue for any dispute under this agreement shall be in the state courts located in Miami-Dade County, Florida and the Federal courts of the Southern District of Florida. EXHIBITOR irrevocably and unconditionally agrees to subject itself to the jurisdiction of those courts; waive any objection to the laying of venue of any such action or proceeding in any such court; and waive and agree not to plead or claim that any such action or proceeding brought in any such court has been brought in an inconvenient forum.
